Fundraising - United Arts operates in a fiscally conservative manner and prepares its budget on a forward-funding model, meaning funds raised during the annual campaign in one fiscal year are restricted to fund grants and operations in the following fiscal year. This may result in net income or a deficit depending on the timing of when funds are raised and expended. The forward-funding model ensures the agency has the committed funds on hand each year to fund the grants and operations proposed in its annual budget. United Arts actively seeks funding opportunities for arts and cultural organizations through annual fundraising campaigns. United Arts coordinates the largest collaborative fundraising campaign in support of arts and culture in Central Florida. Fourteen of the region's cornerstone arts and

Investing in the community - United Arts invests directly in the arts community through grants, collaborative fundraising and contract service opportunities. United Arts' two core grant programs that support arts organizations and individual artists throughout the four-county region are: 1) Operating Support Grants (OSG) provide stabilizing operating support for the region's arts and cultural organizations with full seasons of programming and operating budgets in excess of \$25,000. In FY18, \$1,480,000 in funding was awarded to 37 organizations. 2) Mini Grants - This program provides much needed funding in support of the numerous fairs and festivals that celebrate and honor the region's diversity. In FY18, United Arts awarded \$30,000 in Mini Grant funding to 22 nonprofit arts and

Arts Education Programming - Statistics show that children who have arts credits in their curriculum have improved performance, are more likely to stay in school and are more likely to graduate. Our investments in the arts -- over \$150 million since 1989 -- ensures that the region's arts and cultural offerings are accessible and as varied as the people that engage in them.

United Arts supports more than 60 arts, science and history organizations by raising and distributing funds, securing and facilitating contracts for services including vital Pre-K to 12th grade educational programming, and by providing technical assistance, advocacy, administrative and advisory services. In FY18, United Arts provided more than \$4.9 million in funding through grants, designated giving and contract service opportunities. curriculum-based arts education services to OCPS students in K-12 (contract amount - \$454,656). In FY18, this contract facilitated 97,878 K-12 curriculum-based arts education experiences. United Arts actively seeks grant opportunities to increase the breadth of arts education experiences each student will have and the number of students that are served each year. In FY18, United Arts received \$80,000 in grants specifically for arts education throughout Lake, Orange, Osceola and Seminole counties, resulting in an additional 47,707 arts education experiences these student would not otherwise have had access to. In FY18, United Arts completed the second year of a two-year creative industries curriculum development program funded through a grant from the JP Morgan Chase Foundation. Through a collaboration with United Arts, Valencia College, and the School District of Osceola County, this funding will allow a planned STEM (Science, Technology, Engineering, and Mathematics) high school to add arts to the curriculum, making it a STEAM school (opening fall of 2018). Over five hundred students have registered for the first year of the program. This is United Arts' second grant of its kind from the JPMorgan Chase Foundation, with the first funding the creation of a pilot creative industry back-of-house skills program at Evans High School (OCPS). Evans is now an Arts Magnate school. In these programs, participating students can graduate high school with either technical skills certifications or continue on for a two-year or four-year degree. Students enrolled in the program have opportunities to intern with art, science and history organizations as well as local theme parks, convention centers and other creative industry environments and work with creatives in their fields to get firsthand job experience, then go on to paid positions in the regions creative sector.

The magazine is also offered as a donor premium for contributions of \$50 or more.
